Each submission for the Concept Competition must conform to the following mandatory requirements:

- One single-faced 30" x 40" x 1/4" foam core board to include:
  - An illustrated concept or storyboard
  - Additional graphic information the entrant deems pertinent (up to 2 additional pages)
  - A maximum of 500 words explaining the concept idea
  - No three-dimensional attachments to the board are permitted.
  - The board must not contain any marks, information or names identifying the individuals or organizations that submitted the board.
  - An unmarked, sealed envelope containing the entry form, payment and names of the competition participants should be taped to the back of the board.
  - All text and information must be in English and a minimum of 14 point (1/8 inch) type size.
  - Boards must not be framed or covered in plastic or glass.

The proposed project must be a :30 television public service announcement about DOMESTIC VIOLENCE PREVENTION based upon the winning entry of the Concept Competition. It must be viable to shoot the proposed project in Minnesota within a one to two day period.
